

RSES Company Competence List

The list indicates companies that employ security engineers or specialists whose competence has been assessed by a peer-reviewed assessment of a registrant's application that considers their experiential learning, Continuing Professional Development (CPD) and underpinning knowledge.

A Registrant at the Principal Grade has demonstrated a level of competence in their security engineering category which is broadly equivalent to Chartered Engineer level. A Registrant at the Ordinary Member Grade has demonstrated a level of competence in their security engineering category which is broadly equivalent to Incorporated Engineer level.
